4. Presentation by Fox Lawson on the compensation and classification study.

Christine Lowry-Nunez, of Fox Lawson and Associates reviewed the overall process and phases of the compensation and classification study. Ms. Lowry-Nunez discussed the purpose of the study was to create a compensation and classification system that was competitive with other labor markets; create internal equity and provide a strategic plan. She also discussed the employee involvement that included the completion of the Position Description Questonnaire (PDQ), panel meetings and status updates. Ms. Lowry-Nunez reported that the overall results showed that salaries were 24% market, but that the fringe benefits are comparable.

Council asked what type of employee was being lost to other jurisdictions. Staff replied technical and line staff. Council complemented the thoroughness of the study.
