

Minutes Joint Session with Planning and Zoning Commission and Work Study and Possible Executive Session Oueen Creek Town Council

1. Call to Order

The meeting was called to order at 5:07pm

3. Joint Session: Discussion and direction to staff on the library exterior design concept.

Management Assistant Tracy Corman gave a brief review of a team brainstorming exercise on the exterior design and the Library Committee recommendation. Dawn Brown, reviewed the design process which resulted in three concept designs: contemporary, traditional and playful. Ms. Corman reviewed the public's response to a widely distributed questionnaire. Those results were: Elevation A: 13%; Elevation B: 16% and Elevation C: 25%. Ms. Brown reviewed the elements of each design.

Discussion included the shade element(s) on the west wall; amphitheatre location; materials used on Elevation A. There was also discussion in regard to wanting a compatible/complimentary elevation to other Town Center projects while keeping the library distinct.

Consensus of the Town Council and Planning and Zoning Commission was to move forward with Elevation "C".
