4. Presentation and discussion of Fee Philosophy for the Parks & Recreation Department.

Management Assistant Katie Crevda reviewed the Recreation Advisory Board recommendation for adopting a policy to set fees in a uniform matter for recreation programs. Council Member Wootten, Chair of the Recreation Advisory Board, commended staff for working with the Board to create the philosophy structure.

5. Presentation and discussion on transportation strategies for the community.

Management Assistant Mark Young gave an update on transportation issues; improvements and current needs; "gateway" status between Maricopa County & Pinal County; and current projects including the Improvement District, Ellsworth Road and Riggs Road. Mr. Young also reviewed possible transit options and the five-year transportation improvement program (TIP).

Planning Consultant Wayne Balmer gave a brief overview of the Proposition 400 projects, of which no roads in Queen Creek were considered for funding. He said the County had used outdated data. Mr. Balmer discussed possible north/south access options, including Meridian Road which would benefit Pinal County residents.

Mr. Balmer stated that transportation needs should be shared by Maricopa County, Pinal County, MAG, partnerships with Mesa & Gilbert and state and local transportation funding. Mr. Balmer introduced a proposed new statewide program, LCAT (Local Circulation Arterial Transportation Program). Mr. Balmer stated that legislative help will be needed as well as experienced lobbyists to assist staff in presenting the program in the next legislative session.

Council discussed supporting the initiative and fixing problem areas before commercial centers are completed. Council also asked what the funding timeline might be if the proposed LCAT program is successful. Interim Town Manager Kross responded possibly next calendar year.
