Town Council July 18, 2012





Background

- November 2011 the Town Council amended the sign ordinance to delete "weekend directional signs" and replace them with "sign kiosks".
- Mr. Jackson Moll of the Home Builders Association of Central Arizona requested the Town consider development of a homebuilder sign program, as has been done in other communities
- Ms. Debbie Oleskow has been working with homebuilders and staff on a propose change

Current Ordinance

- Article 6.16 of the Zoning Ordinance regulates temporary real estate signs
- Home builder signs included in several paragraphs in Article 6.16 Sign Regulations



Proposed Change

- Reviewed other communities
 - Gilbert and City of Maricopa
- Proposed Home Builder Sign Plan
 - Revise Article 6.16 Sign Regulations to add a Paragraph D. which would combine all temporary sign provision in one location
 - The Home Builder Sign Plan to be approved in conjunction with the model home sales complex



Home Builder Sign Plan

- One <u>subdivision</u> sign per arterial street frontage – 12' in height, 48 square feet including "sign rider" panels (currently 8' and 32 square feet)
- One model home location sign 12' in height and 48 square feet including "sign rider panels", for each model home location (currently 8' and 32 square feet and assumes only one model location)

Home Builder Sign Plan

- One flag pole 60' in height per model home complex location (45' currently)
- Builder attention flags:
 - 15' in height and 15 square feet in area
 - 5 flags per model home in complex
 - 20' separation between flags
 - Each model home complex allowed 5 flags per model home

(Currently allow flags 6 square feet, unlimited number)

Home Builder Sign Plan

- Two off-site directional signs 6 square feet each (currently allowed - clarification of current wording)
- Two model home complex directional sign (new)
 - 6 square feet, 4 feet in height
 - Directions to parking, other model complexes in the subdivision, etc.

Home Builder Sign Plan

- One on-site future development sign per arterial street frontage (new)
 - 8' in height, 32 square feet
 - To provide the name and contact information of the future homebuilder
 - Installed in advance of the sign plan,
 with documentation of property
 ownership
 - Permitted for 1 year, or until approval of a Home Builder Sign Plan, whichever occurs first



Summary

- Comparable to Gilbert and City of Maricopa
- Requirements combined in one area
- Responds to home builder concerns
- Mostly revisions of current standards
