- If General Plan is allowing higher density, then does this requires greater services?
- Advocating means committee members going out and asking citizens their needs and wants. Committee members should be suggesting that citizens communicate with council members or that they go to Council Meetings to stay on top of what is happening. Committee members should be talking to partners to hear what their needs and wants are. Part of the committee's role is to communicate all this information to Town Council.

Final goals included:

- 1. Survey Residents needs, wants, etc. Review level of service. Survey new residents with water turn on.
- 2. Improve communication to and from Council
- 3. Be an active participant volunteer at upcoming events, talk to participants, talk to neighbors.
