- C. Finance Director Scott McCarty provided an update on the Focus Group meeting schedule through March 2018 and the group's tasks for providing updates to the Town's committees on respective fees. He also reviewed the Council's role in reviewing and accepting the fee reports and land use assumptions when complete; set the updated fees to be effective on same date; and decide how to use the \$6.5 million placeholder towards transportation and/or parks funding; and issue the bonds.

Mr. McCarty discussed the communications plan that includes a dedicated web site for the Focus Group and schedule of public forums, Focus Group meetings and Town Council meetings in order to have fees approved and effective in September 2018.

The purpose of issuing bonds, including the amount, structure and approval were also discussed.

Council Members Oliphant and Wheatley requested this item placed on the agenda. Assistant to the Town Manager Tracy Corman reviewed a possible program outline, facilitated by Banner Ironwood Hospital that would supplement the school district programs.

Ms. Corman also presented some alternatives (including associated costs) that included 1) taking no action; 2) partner with the Queen Creek School District on a presentation at a Council meeting; 3) have a series of six events through the year (approximately \$3000 in staff time for year).

Sharon Linn, Banner CEO, provided additional details on what topics/resources a a community session might include.

Council discussed the importance to the community on knowing what resources are available and being able to talk openly about the suicide and other issues; focusing on teens & parents and providing a neutral environment to allow the open discussions.

B. Discussion and possible approval of Resolution 1169-17 adopting the updated Town Center Plan.

Economic Development Director Doreen Cott gave an overview of the update process and introduced Vern Swaback Jeff Denzak with Swaback & Associates, the Town's consultant.

Mr. Denzak commented that the current Town Center Plan was used as the framework for the update with a focus on the "core" Ellsworth & Ocotillo area, with recommendations to avoid chain/big box development, additional east/west connections to Ellsworth Loop Rd; and creating brand identity.

Council commented that the plan was pro-active, allowing the Town to be more progressive and continue to work with Town Center stakeholders.

Ms. Cott commented on the recommendation for an overlay district and explained that input from the Town Center stakeholders would be needed and could take 6-9 months for the public process.

C. Consideration and possible approval of a new striping plan for Ellsworth Road from Ocotillo to Ellsworth Loop Road to include additional parking and green bike lanes and the reallocation from contingency not to exceed \$100,000.

Transportation Engineering Manager Mohamed Youssef, as a follow-up from the September 20, 2017 Council meeting presentation, reviewed two options for the striping plan for the portion of Ellsworth Road between Sierra Park Blvd & Ocotillo Road as part of the pavement preservation project.

- Option 1: Keep existing center two-way left turn lane and add bike lanes on east & west side of road; removing 20 existing parking spaces with an option for green bike lane paint (\$70,000)
- Option 2 (recommended by Transportation Advisory Committee): remove existing center two-way left turn lane between Crewse Lane & Ocotillo Road; add bike lanes on east & west side of road with an option for green bike lane paint (\$70,000); and add 40 parking spaces on east side of road (\$30,000).

**MOTION:** To approve Alternative 2 without green paint:

Recreation Superintendent Adam Robinson reviewed the park naming policy, public outreach & participation and the Parks & Recreation Advisory Committee (PRAC) review and recommendation. Mr. Robinson presented the three recommended names from PRAC:

- Queen Creek Adventure Park
- QC Lakeview Park
- QC Community Park

Council discussed a preference for unique names to Queen Creek and discussed several of the other park names submitted: Mansel Carter Park; David Croxell Park; Doodle Bug Park; and Appleby Lake Park. Consideration was also given to include reference to the lake feature in the name.


