A. Discussion about Results of 2017 Citizen Survey.

Communications, Marketing & Recreation Director Marnie Schubert gave a brief history of the survey process and introduced consultant Kathryn DeBoer of WestGroup Research.

Ms. DeBoer presented the results of the 2017 Citizen Survey. Ms. DeBoer outlined the background and methodology of the survey and presented the key findings, which showed that residents enjoy living in Queen Creek. She reported a significant increase in satisfaction percentages across many categories.

B. Discussion and presentation regarding the Town's upcoming Home Rule (alternative expenditure limitation) renewal

Finance Director Scott McCarty provided information on the Arizona Expenditure Limitation, which was enacted by State Legislature in 1979/80 to limit local government spending. He said it sets the cap on what the Town can spend on goods and services. Mr. McCarty outlined the two options:

- Home Rule Option: Queen Creek currently operates under the home rule option, which has to go to voters every four years for approval. The home rule option will expire in June 2019 and will need voter approval for renewal at the August 2018 Primary Election. Mr. McCarty reviewed the election timeline, which includes two public hearings. He explained that the home rule formula does not take into account the demands of a fast growing community and stressed that renewal is critical in order to maintain existing services.
- <u>Permanent Base Adjustment Option</u>: Mr. McCarty said this option establishes a new permanent expenditure base that increases annually based on inflation and population. This option does not need an election every four years, but would need one-time voter approval to establish. He said this is an option to consider in the future.

Public Information Officer Constance Halonen-Wilson outlined the communication plan that will begin in April to educate voters on the importance of home rule option for the Town.

Council asked if we could hold a home rule election and the permanent base adjustment election concurrently. Mr. McCarty said yes it is possible; however waiting to 2020 for the permanent base would give the Town more time to analyze the cap and educate voters. Council had further discussion on the importance of educating the community on Home Rule and Permanent Base Adjustment.

Mayor Gail Barney thanked Captain Munley for 32 years of service in law enforcement and introduced Captain Munley's family members who were in attendance and thanked them for their support.

Captain Munley thanked the Council, staff, residents of Queen Creek and his family. He introduced the new MCSO Captain Richard Johnson.

K. Consideration and possible approval of Work Order #11 and Work Order #12 with AJP Electric, Inc., in an amount not to exceed \$616,986 for construction of two new traffic signals at the intersection of Ellsworth Road and Via de Palmas Road (CIP Project I0060) and the intersection of Hawes Road and Riggs Road (CIP Project I0028) and approval of necessary budget adjustments

Transportation Engineering Manager Mohamed Youssef said staff received several requests from residents to install a traffic signal at the intersection of Ellsworth Road and Via De Palmas. Mr. Youssef outlined the process to install traffic signals and said the first step was to monitor traffic to see if a traffic study was needed. Based on those results a warrant study was performed and it was determined that the intersection met the threshold for a signal based on criteria in the Manual on Uniform Traffic Control Devices. Mr. Youssef explained that once a warrant is met the signal must be installed in a reasonable amount of time. He said the design stage is complete and construction for the new light is the next step.

Council discussed concerns from residents who were in favor of the light and those opposed to the signal. It was noted that a signal was always planned for the intersection at some point and developer donated funds were set aside for that purpose.

Council asked if once the signal is installed is the Town required to follow national standards for traffic light signal sequences. Mr. Youssef replied that we have to adhere to national standards for several reasons (1) consistency (2) to meet driver expectancy and (3) liability and possible loss of federal funding if not followed. He added that the light must be fully operating once installed.

There was some discussion on the option for more outreach to residents or further studies before installing the traffic light. Public Works Director Troy White responded that staff does not recommend a delay and stated that during peak hours vehicles making left turns are facing a challenge. He said that once we do a warrant study we must move forward for safety concerns.

Council had further discussion on traffic flow, the importance of public safety and resident outreach. Council Member Hoffman requested a future discussion on national standards and policy.

The following submitted a comment card in favor: Jane Litchfield (Queen Creek), Lonnie Hurst (Queen Creek).

Development Services Director Chris Anaradian said this was the third presentation to Council on public art and the process to establish a Municipal Arts Commission. He said a committee comprised of community members was formed, at the request of Council, to make recommendations regarding public art in the community. Mr. Anaradian said the forty-member group convened over the summer and had extensive discussions on various topics such as place making; art as a means to promote Queen Creek history, and the role of art in future projects. Mr. Anaradian said the committee recommended the following steps:

- Resurrect the Arts Commission; establish by-laws and processes; and select members.
- Establish a mechanism (501c3) to receive public gifts and contributions.
- Establish an account in the town budget for funds and donations

Council discussed the importance of public art and getting input from residents, businesses and stakeholders. There was discussion on the process for donations; 501c3s; the role that town and local government should play in an art program; and the use of grants.

Mr. Anaradian briefly discussed the role of the commission. He explained that the newly appointed commission, with input from stakeholders, would initiate program details and staff would have an advisory role. He said the commission would not set policy and would report to Council with recommendations for each aspect of the program.

Council had further discussion on the purpose and benefits of forming a 501c3 and asked Mr. Anaradian for clarification. Mr. Anaradian responded that we can already accept gifts as a municipality without forming a 501c3. He explained that a benefit of forming a 501c3 would be to include people who specialize in seeking contributions whereas the arts commission would include artists and local community members. Mr. Anaradian asked the Council for direction on forming a 5013c going forward.


