  - A. Presentation by Maricopa County Recorder Adrian Fontes and Election staff on upcoming elections; vote/ballot centers and ballot-by-mail elections.

Maricopa County Recorder Adrian Fontes, introduced Maricopa County Elections Director Rey Valenzuela and Pinal County Elections Director Michele Forney.

Mr. Fontes discussed the Town's upcoming all mail ballot election in May. Ballot Centers with ballot drop-off and replacement will be available for extended times prior to Election Day. Mr. Fontes explained how the Sitebook technology works for a voter to check in and print a ballot specific for that voter. He also discussed the security of ballot by mail elections that uses signature verification rather than photo ID and the reduced costs for overhead and staffing with ballot by mail elections.

Mr. Fontes reviewed important dates regarding voter registration; dates to mail ballots; and options for election day voting. Public outreach programs, events and communication were highlighted. He also noted that there is a bill in the Legislature that would allow ballot by mail elections for counties as well.

Council asked for the status of precinct updates. Mr. Fontes responded that they occur after a general election and the new precinct maps were approved by the Board of Supervisors in December 2017.

- E. Eagle Scout Recognition Danny Farar was recognized for his project involving 36 volunteers who repaired and installed new irrigation lines, decomposed granite and planted shrubs and tree at a well site.
- F. Presentation by Boys & Girls Club Youth of the Year Tyler Ruof

Boys and Girls Club Director Tyler Bellman explained the Youth of the Year program and introduced Tyler Ruof, who was selected to represent the Queen Creek Boys & Girls Club. Tyler presented his speech that he will use in the March competition.
