On September 20, 2017 the Town Council adopted the "2018 General Plan Update" by Resolution 1165-17. A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF QUEEN CREEK, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON MAY 15, 2018; AND ORDERING THE RECORDING.

WHEREAS, the Town Council of Queen Creek, Maricopa County, Arizona did cause to be submitted to the qualified electors of the Town at a Special Election called and held in and for the Town on the 15th day of May 2018 for the question of a new General Plan; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Queen Creek, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said Special Election, as shown by the poll lists was 4546. (Exhibit A)

SECTION 2. That the number of rejected ballots was 52. (Exhibit B)

SECTION 3. That the votes cast for Proposition 405 were as follows (Exhibit (C):
