Principal Planner Christine Sheehy stated the public hearing was to receive testimony and comments. She reviewed the boundaries of the proposed annexation of approximately 755 acres. Ms. Sheehy also stated that as of December 5, 2018, 58 letters in support and 30 in opposition had been received and provided to Council. She reviewed the next steps in the annexation process, and that signatures can begin to be collected on Saturday December 8, 2018. A second public hearing will be scheduled once 51% of property owners sign with 50% of the property value. Town Attorney Holcomb also explained the public hearing process and public comments.

Mayor Barney opened the public hearing.

Leah Gumm, Encanterra (San Tan Valley), the applicant for annexation, spoke in support of the annexation, commenting on the future Encanterra and annexation vs. incorporation.

Merle Pfeifer, Encanterra (San Tan Valley), spoke in support of annexation and commented on the San Tan Valley incorporation efforts and how annexation gives residents a choice and incorporation doesn't.

Bob Delena, Encanterra (San Tan Valley), spoke in support of annexation and commented on the improvements to Queen Creek roads and shopping during the past five years.

Nancy Naylor, Queen Creek, spoke in support of annexation and commented on the recent annexation of Ironwood Crossing.

Beth Riley, Queen Creek, spoke in support of annexation, and the benefits of annexation.

Erica Christman, Encanterra (San Tan Valley), spoke in opposition to annexation, lack of internal communications and commented on duplicate charges, taxes, fees and services. She stated the HOA is responsible for maintaining inside the gates and current community services are superior.

Laura Moncrief, Encanterra (San Tan Valley), spoke in opposition to annexation. She stated she chose to live in the county and sees no advantage to annexation except higher taxes.

Milt Fernandez, Encanterra (San Tan Valley), spoke in opposition to annexation, and commented that he didn't want to pay higher taxes or pensions.

Helen Schafft, Encanterra (San Tan Valley), spoke in opposition to annexation, and commented on higher taxes, fees and public safety being further away.

Ted Jones, Encanterra (San Tan Valley), spoke in opposition to annexation, and commented on opposition to increased taxes with no additional benefits and his support for Rural Metro.

Gayle Peters, Encanterra (San Tan Valley), spoke in opposition to annexation, and commented on enjoying the amenities of Queen Creek but Encanterra is self-sufficient and don't need services from Queen Creek.

B. Public Hearing on the Town’s Biennial Impact Fee Audit covering fiscal years 2014-15 and 2015-16 and possible approval of Resolution 1241-18 accepting the Town’s Biennial Development Impact Fee Audit Report.

Deputy Finance Director Dan Olsen explained the statutory requirements on how impact fees are collected and spent; audit requirements including holding a public hearing to accept the audit report.

Kevin Byrne, Willdan Financial Services, reviewed the audit objectives and results.

Mr. Olsen explained the 24-month fee hold period on a development and that the Town adopted a new fee schedule with decreased fees that applied to all permits after August 1, 2014 which resulted in some permits being overcharged. He said all permits in the audit period will be reviewed and any refunds will be made to entity who pulled the permit. Mr. Olsen added that new software now verifies the 24-month fee hold period automatically. He added that other jurisdictions are experiencing similar results with the first audit under the new requirements.

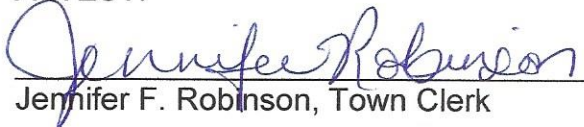
