 - A. Presentation and update on Phoenix-Mesa Gateway Airport by Brian J. O'Neill, Executive Director.

Brian O'Neill, PMGA Executive Director, provided an update on the airport's commercial service and private enterprise activities. Mr. O'Neill's update included the announcement by Allegiant Airlines of two new routes; several new developments including Gateway Executive Park; Skybridge; Hangar 37; Hangar 18

> and the Able Engineering expansion. In addition, the airport is planning renovations to the FBO facility to accommodate the new development. Mr. O'Neill also discussed the cargo processing program and completion of runway improvements. A report on community noise complaints was also presented.

B. Presentation and discussion regarding the status of updating impact and capacity fees.

Mayor Barney declared a conflict and turned the meeting over to Vice Mayor Turley.

Finance Director McCarty provided a status report on updating the current impact and capacity fees. He reviewed recent Council actions that include the funding of the Transportation Infrastructure Improvement Plan (TIIP) and public safety projects by issuing \$75M in bond debt; reconciled impact fee cash balances; and approved a public safety funding policy; water extinguishment credit purchase and water rights purchase.

Mr. McCarty discussed the next policies to be considered: a new revenue credit offset (develop a credit fee to offset impact and capacity fees) and addressing

effluent water costs; combining the water and wastewater divisions into one; and restructuring existing water debt and establishing a repair and replacement reserve.

Mr. McCarty reviewed the schedule of future meetings for additional Council direction; stakeholder meetings and public notice requirements. Mr. McCarty added that the anticipated effective date of new fees is January 2020.

Mayor Barney returned to the dais.

A. Public hearing for annexation case P18-0167 "Ranchos Legante Annexation", a proposed annexation of Maricopa County parcels totaling approximately 71.79 acres, generally located at the southwest corner of Ellsworth and Riggs Roads.


