Mr. Saxe & Ms. Patterson also presented and discussed the materials used that are compatible with Queen Creek's environment (concrete/masonry and colored glass mosaic).

There was discussion on whether the headgate on the sculpture would be an attractive nuisance; adding an additional image of a corn crop; and whether to use ceramic or terrazzo tiles. Mr. Eubanks, the Town's consultant, said that if the concept is in the right direction and is approved, the final designs will be brought back to Council for approval.
