



### Town of Queen Creek Police Services Study


### Introduction

- Follow-up from March 2, 2019 Town Council Annual Strategic Planning Session.
- 2018 and 2019 Council discussed police services at their annual Strategic Planning Session.
- Growth: The primary driving factor affecting police services; importantly this is not intended to be a reflection of the service provided by District 6 staff.
  - 6-10% population growth rate annually over last several years, anticipated to continue over next five years.
  - Current population estimated at 52,000, with the build out population estimated to be 175,000.
  - Over the last five years, there has been a 62% increase in acreage zoned for commercial uses.
  - Overall Town and area urbanization (increased population, higher density, more non-residential, and increased traffic), affecting the need for more control over day to day police program.




### Report Overview

- Determine the required law enforcement resources that will be needed as the community continues to grow and evolve.
- Conduct a comparative analysis of other police departments
- Evaluate the delivery of services and how to maintain appropriate levels of service with Maricopa County Sheriff's Office, a municipal police department, or other option(s).




# HISTORY OF LAW ENFORCEMENT IN QUEEN CREEK

- FY90 MCSO contract established with 25% of one beat.
- FY20 MCSO contract is for six beats (49 sworn officers).
- With the growth and changing needs of the community, the Town regularly evaluates all programs and services to ensure they meet current needs, and law enforcement is just one of those services.

  - Five-Year Strategic Plan for Law Enforcement, 2016




### Expectations and Desired Outcomes for Town Law Enforcement Services

## Expectations and Desired Outcomes for Town Law Enforcement Services


- Intelligence Led Policing

## Expectations and Desired Outcomes for Town Law Enforcement Services


#### Communication

- Town's narrative




### Law Enforcement Options

  - Timing




### FINANCIAL CONSIDERATIONS

#### 5-Year Financial Plan for Queen Creek Police Department

Personnel	\$869,007	\$9,475,323	\$10,243,182	\$11,063,471	\$11,939,552
Operations	\$274,573	\$1,754,649	\$1,796,740	\$1,891,942	\$1,996,226

Total	\$7,023,676	\$11,844,972	\$12,654,922	\$13,676,413	\$14,692,828

- This 5 year plan does not require new taxes or revenue sources, it can be maintained within the Town's current revenue projection.
- The study reports \$825,000 in estimated total impacts to other Town departments, however \$100,000 is one time costs and \$350,000 is for positions already included in Town's 5 year financial plan.
- The 5 year MCSO contract projections do not account for increases in wages or administrative fees, or the current financial impacts to other departments.
