  - B. Public Hearing and possible action on Ordinance 715-19, Queen Creek Olive Mill PAD Rezone (P19-0026), a request from Sean Lake, Pew and Lake PLC, on behalf of Frantoio Hills LLC, to rezone approximately 47.5 acres from R1-43 to Agritainment/PAD to allow the existing Queen Creek Olive Mill and its future expansion, located at the northeast corner of Combs and Rittenhouse roads.

Planner Steven Ester presented on the PAD Rezone of approximately 47.5 acres from R1-43 to Agritainment with a PAD overlay, bringing the property into conformance with the General Plan and South Specific Area Plan. The Zoning will allow future expansion of the Olive Mill and other new projects in the future. A neighborhood meeting was held on June 26, 2019 at Schnepf Farms and no public input has been provided to date. The case was then presented to the Planning Commission at their regularly scheduled October 9, 2019 meeting. Again, there was no public input and the Planning Commission recommended approval. The applicant Sean Lake also presented on behalf of the Olive Mill and the Rea Family.

The Public Hearing was opened. No one came forth and the Public Hearing was closed.
