Public Works Director Troy White and Marketing, Communications and Recreation Director Marnie Schubert provided the Council with options for trail improvements in and around Riggs Road and Horseshoe Park & Equestrian Centre. Two videos were presented relative to the trail improvements in and around Riggs Road and HPEC, and "Know How to Drive Around Animals". Ms. Schubert noted the video was shared on social media platforms and in the equestrian community. Comments and questions have been submitted from the community and staff is responding as well helping to drive the safety message to drivers to maneuver safely around animals. In addition, the *Drive to Arrive* video is planned for release on social media outlets on December 20, 2019.

  - A. Consideration and possible approval of a Naming Rights program for Horseshoe Park & Equestrian Centre (HPEC).

HPEC Manager Tim Lynch provided the Council with background on the efforts made to establish a naming program for HPEC. To date, there has been over \$200,000 donated to the Friends of Horseshoe Park for the covered arena project, purchased a pre-fabricated building, and donated materials to the Town. The Town then funded to assemble and erect the building. To note, Dawn & John Chapman donated \$50,000, and the AZ Cutting Horse Association (AzCHA) donated \$80,000; over 50% of the total donations.

In an effort to recognize their generosity, Mr. Lynch noted that a naming rights program would accomplish two goals. It would fist honor the donors by naming Arena 1, "The Chapman Autoplex Arena" for a period of 10 years, and & naming Arena 3 after AzCHA for a similar period of time. Secondly, naming the buildings will help create a market for building at HPEC that does not currently exist. Mr. Lynch also provided alternatives for the Council's consideration.

Discussion ensued regarding the need for a policy, procedure to bring forward aesthetically pleasing and cost effective signage for Council support. Follow up discussion with the Town Attorney to be had to review and discuss best and appropriate structure for donated funds. Further discussion held regarding a shortfall of \$2,000 (\$500 of which was personally offered as a donation by Vice Mayor Benning), and that the Town not be responsible for it. Town Attorney Scott Holcomb commented that this is not to be presented as a policy but rather a program.
