A. Public Hearing and Possible Action on Ordinance 718-20, case P19-0186 Madera West Estates PAD Amendment, Request for a PAD amendment to Ordinance 553-14 to rezone from R1-9/PAD to R1-9/PAD and R1-7/PAD for a 219 lot future residential development, located at the southwest corner of Queen Creek Road and 220th Street.

Mayor Barney recused himself due to a conflict. Council Member Benning ran the meeting at this point as Vice Mayor Wheatley joined telephonically.

Planner Kyle Barchilleo presented the case and recommendations for approval from the Planning Commission. On behalf of Madera West, the applicant Gary Hayes presented on communication efforts and results from neighborhood feedback.

Council Member Benning opened the Public Hearing. Mr. Jeff Ruegsegger at 21665 E. Nightingale Drive noting "The development area rezoning doesn't make sense. High-density in this are diminishes Queen Creek's equestrian feel. This is why we moved here, and it feels like a broken promise. We understand development will happen, but this goes too far. Let's keep QC as rural as possible. This just means more cars, pollution, traffic in the area! Growth is ok but should be done with QC original feeling in mind. We don't need high density everywhere, especially jammed in between all the other low-density existing properties." Additional comments in opposition were given by Daniel Morris, 21712 E Nightingale Dr and Rick Black, 21720 E. Twin Acres Drive. The Public Hearing was closed.


