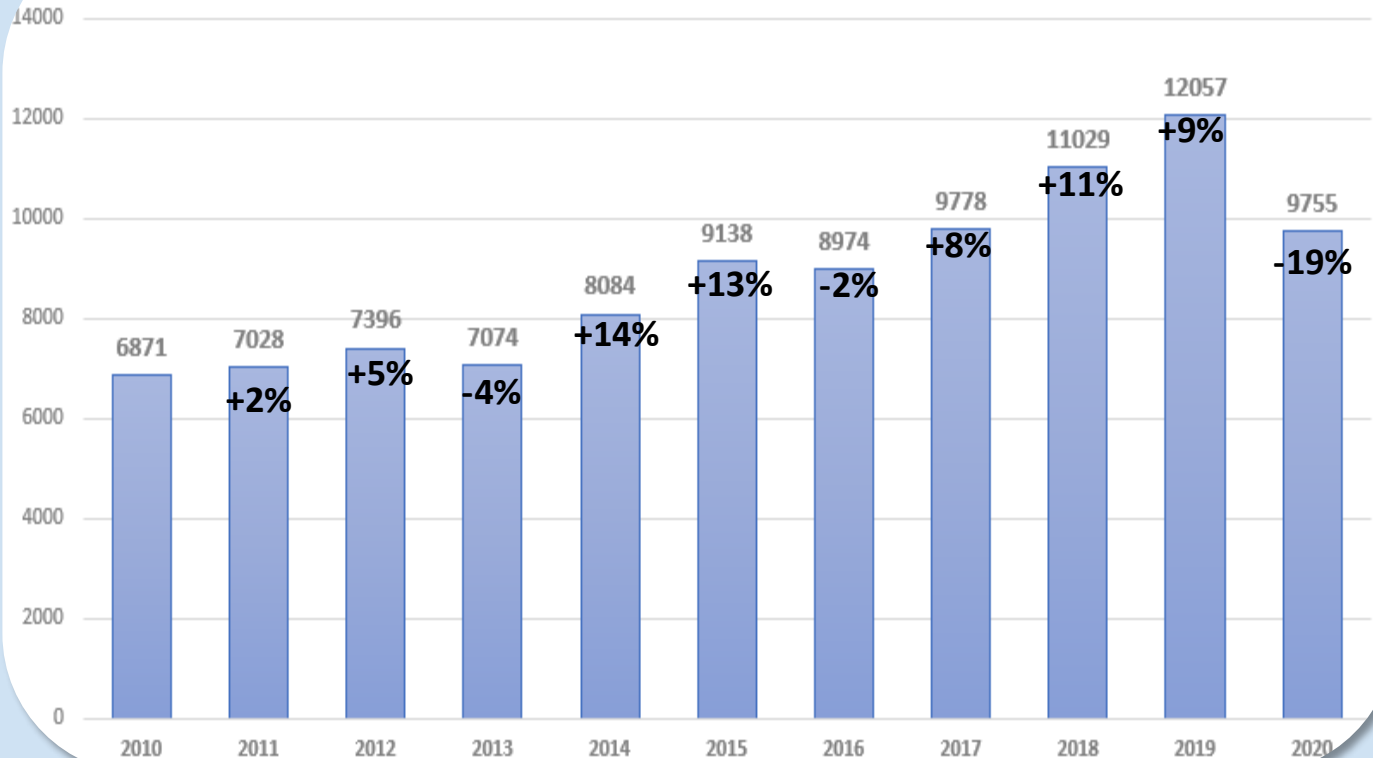

Calls for Service 2010-2020



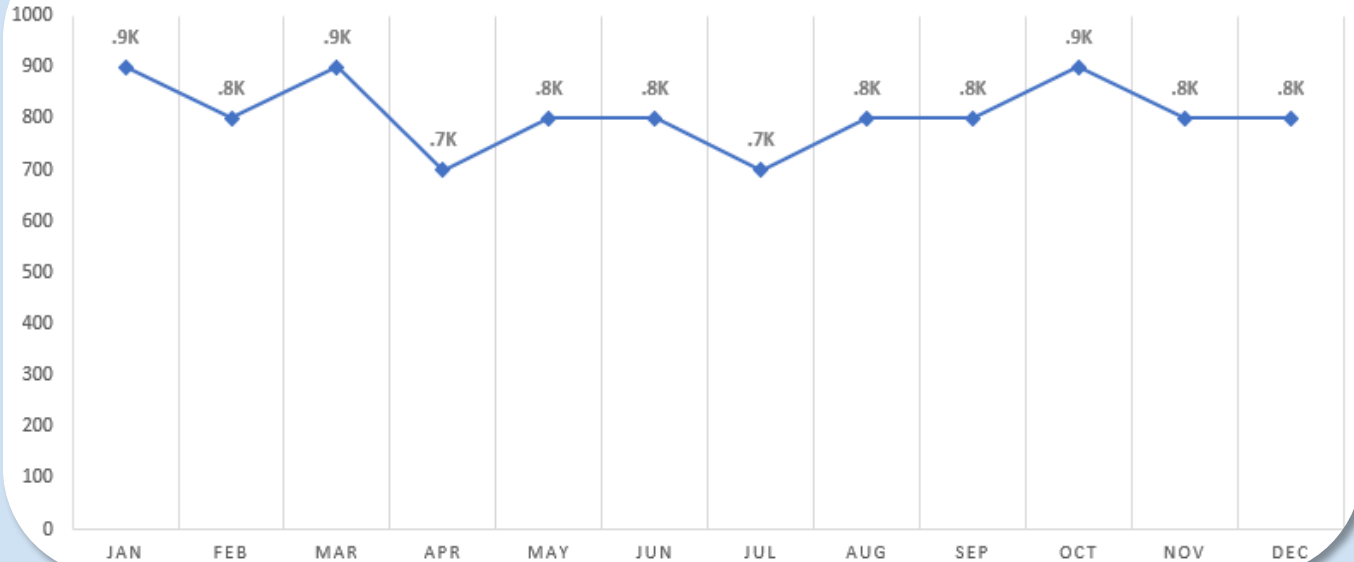

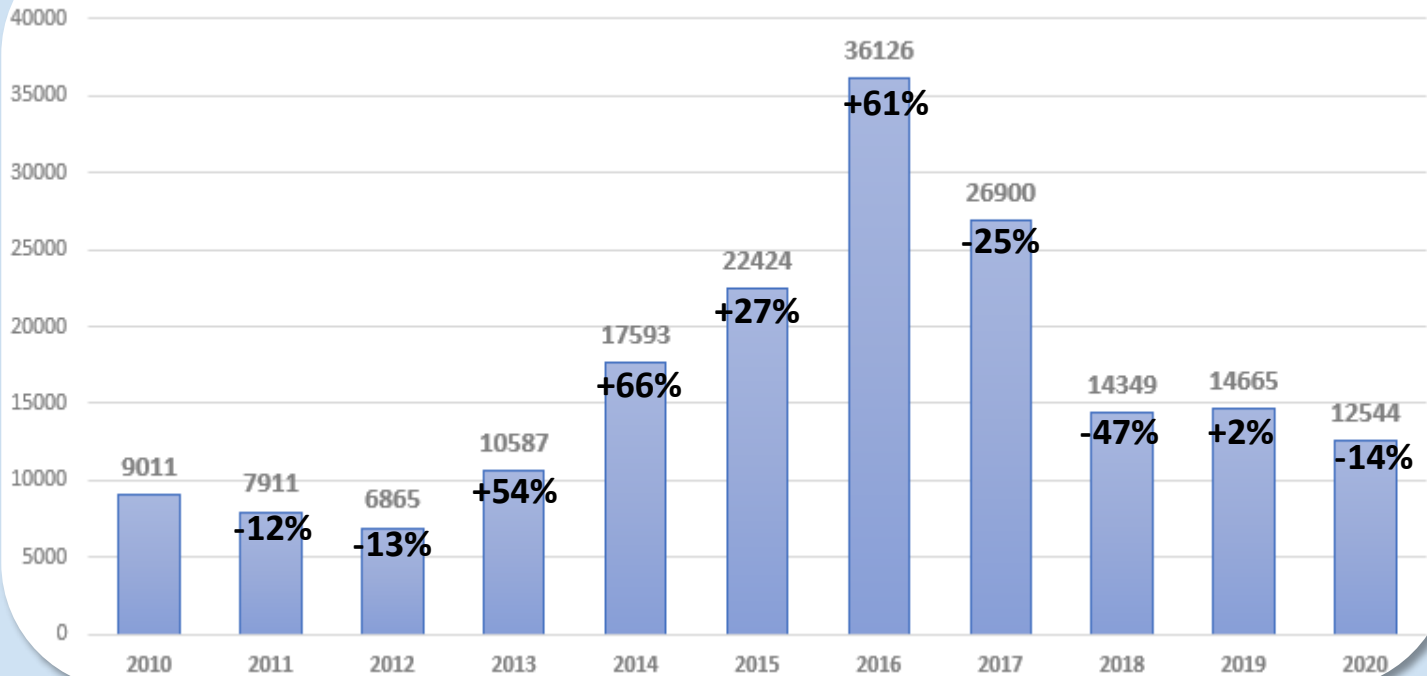

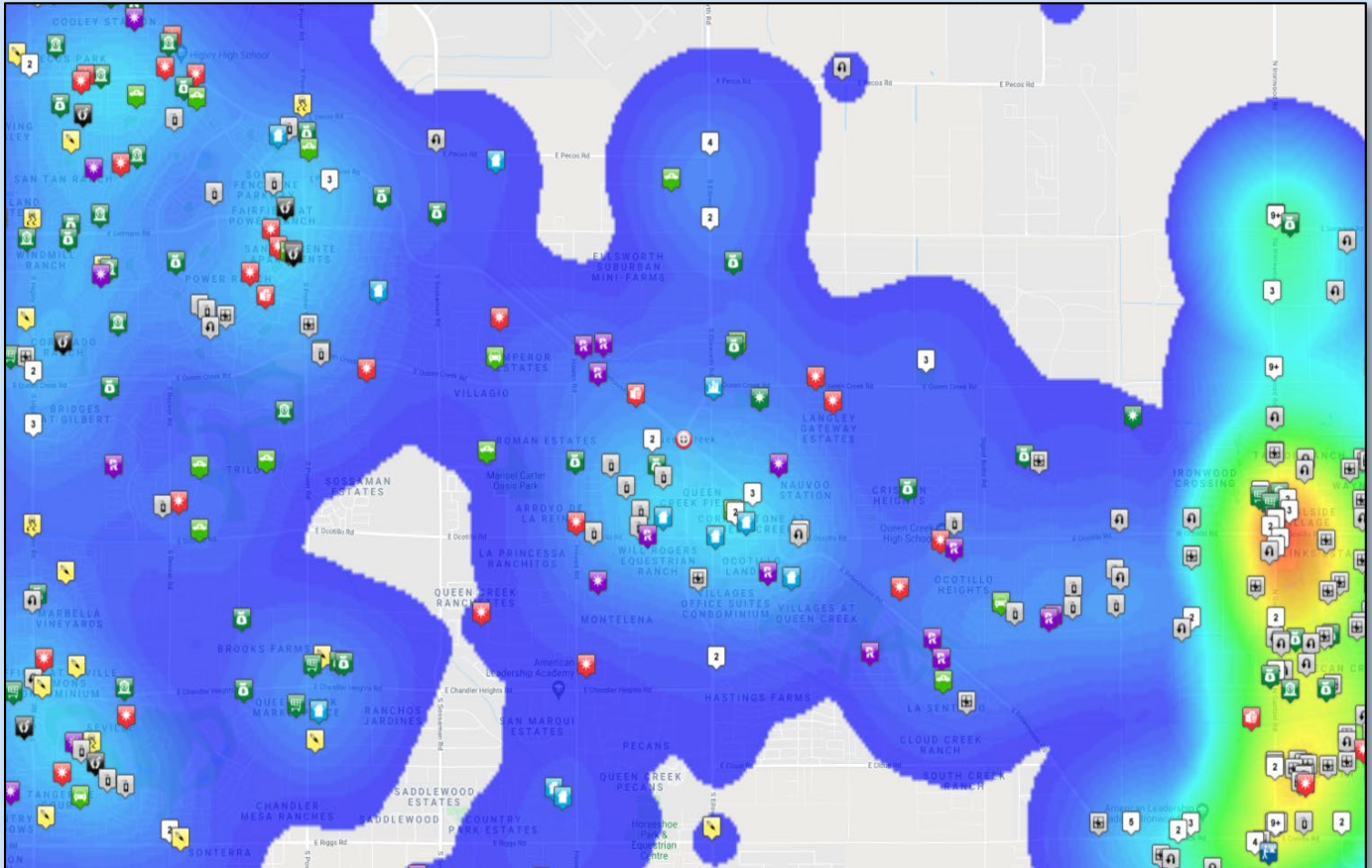
On View Events by Year

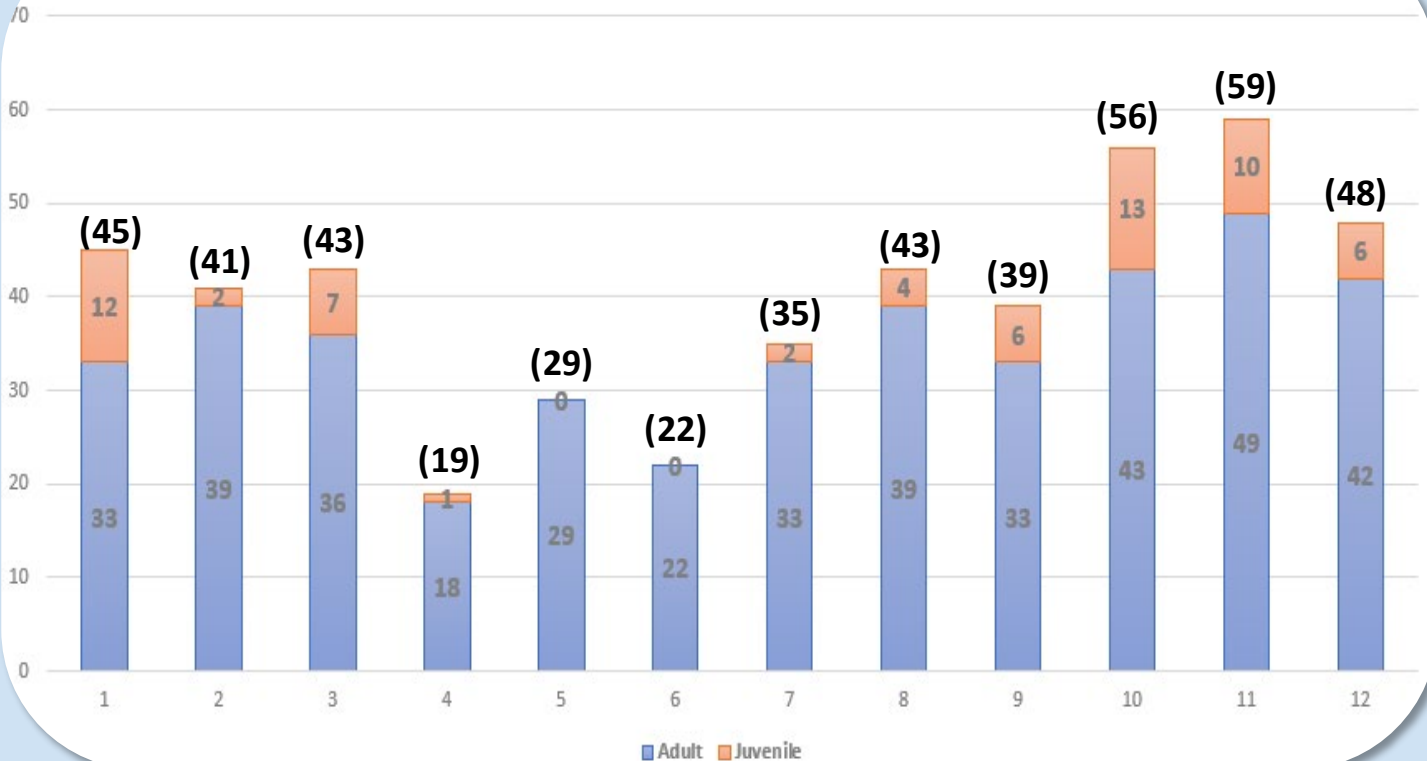

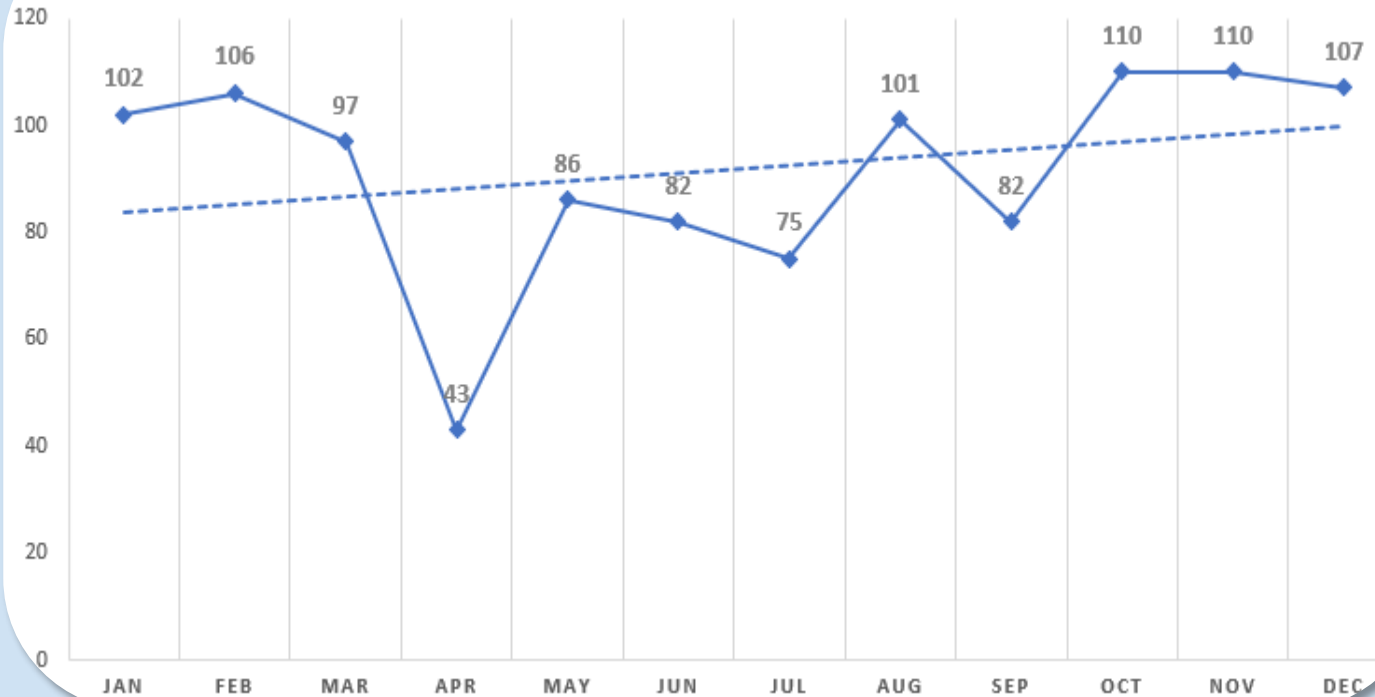
- Speeding (53%)

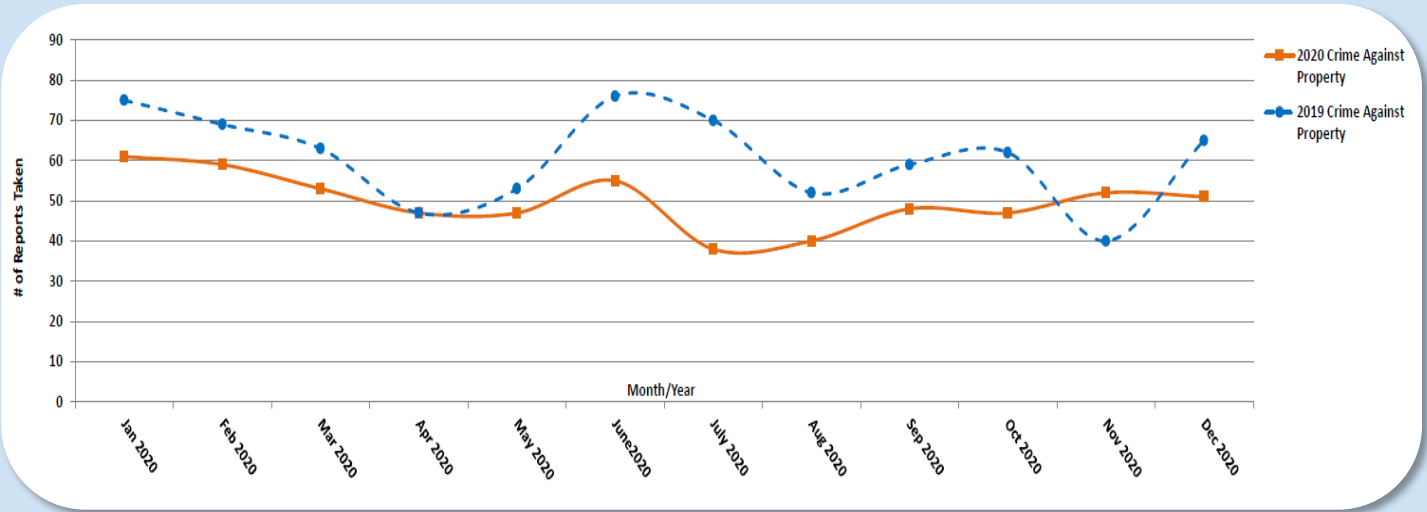

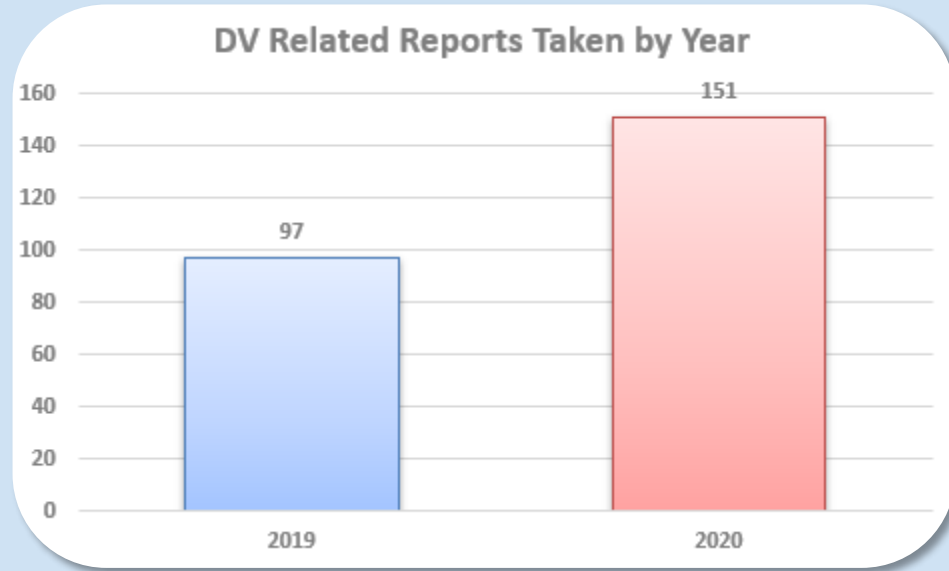

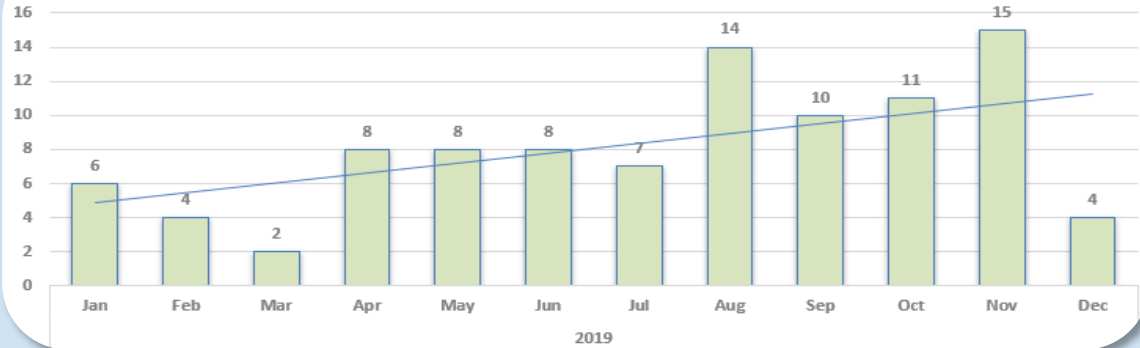

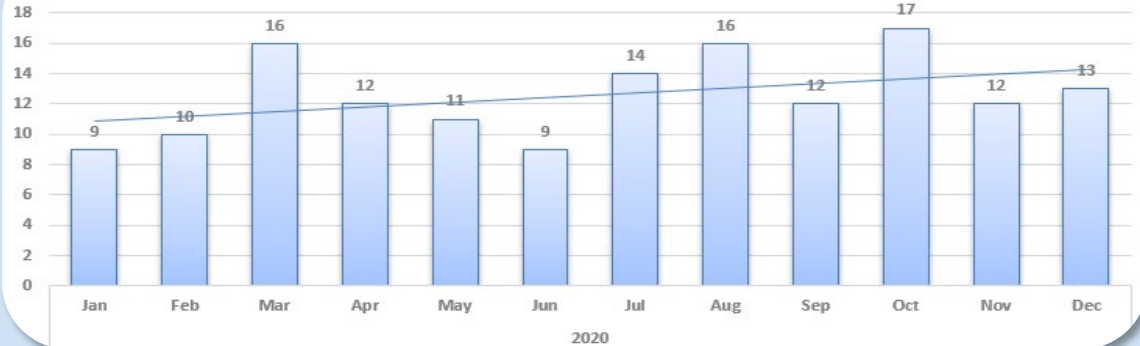
