#### D. Discussion on East Park site amenities - Adam

Adam provided an update of the East Park site amenities including a history on how the <u>Discussion/Questions/Comments:</u>

- It would be helpful to understand how much parking is available in each section of the park. When we do the more detailed design review, will want to know how many spaces are allotted to each part of the park
- Would want to see this park address some of the safety concerns parents have discussed with me regarding the Mansel Park playground being near the lake and lack of line of sight throughout the main play area. Also heard there are not enough swings and play areas for older children, want to include the Warrior Ninja type pieces
- Agree with the need for more cross training or Warrior Ninja type course equipment that is aimed at older children and adults.
- More innovative, more groundbreaking, more Green. Can we partner with ASU engineering students to do a student project to be more sustainable and innovative?
  - Yes, innovation is always something we look to do and staff will talk to the design team about if and how we can reach out and incorporate a student team.
- Likes Concept 2A but any of the designs with the soccer fields grouped together is there a way to orient them so there is parking nearby them all for handicap/disabled or give an opportunity for a designated drop off area, appears like a far distance to walk
- Growing trends with permeable pavement or white pavement versus black top for heat shield, new concept on types of surface. Upfront expense but could apply for LWCF funds/grants, would absolutely help with application and process.
- Nice to have parking lot proximity to the ballfields but can also be a car damage issue/safety concern, keep in mind to allow for warm up space around the ballfields, caution that using the minimum size lake eliminates the ability to use the lake as a resource during drought seasons or major equipment malfunction.
- Would want to see proximity and measured walking distance to key amenities later on. Spoke to people at Mansel Park and they did appreciate the fence around the lake near the play areas and a couple of comments about line of sight with the elevated hill.

- Since we are not calling this park the Queen Creek Sports Complex anymore, would like to name the park, instead of just calling it East Park Project
- Trees in between the fields are not conducive to use as families bring lots of popups and the trees just get in the way.
  - Ground Maintenance would agree that it is very challenging to keep the trees between the fields healthy. Also, material falling from the trees degrades the quality of infield material, leading to additional maintenance and faster replacement times.
- Are there any trail connectors to the park?
  - Ryan Road SRP easement has a trail running all the way to Ellsworth Road. There is also the sidewalk plus multi-use path trail along Signal Butte south to Ocotillo - not a wash trail but does have the sidewalk and 10 ft decomposed granite (DG) path.

- Non-Town events are up and running including QC Feastival and QC Family Market in Town Center and Schnepf Farms' Pumpkin and Chili Party.
