- Maricopa County IGA for Sossaman and Germann Rd, IGA for Chandler Heights and west of Power Rd, IGA East Park Sports complex and Crismon Road Regional Drainage Improvements, IGA Rittenhouse Rd and Queen Creek wash bridge
- Town of Gilbert IGA for Chandler Heights west of Power Rd
- Pinal County IGA for portions of Ironwood Drive as well as for Meridian Road from Combs Road to SR24
