# Food Truck Licensing Current Process

- Peddler's License Cost - \$250 per calendar quarter (\$1,000 annually)
- Temporary Use Permit (TUP) - \$250 per location per 90 days



# Food Truck Licensing Option 1



- Peddler's License Cost - \$250 annually
- Includes a Zoning review and Site Plan review
- Eliminate the TUP requirement for mobile vendors
- Processed similar to the Home-Based Business
- Considerations:
  - Requires a Site Plan
  - Reduces potential for of issues in the field and resources needed to correct issues

# Food Truck Licensing Option 2



- General Business License Cost - \$60
- Application lists the requirements for food trucks
- Eliminate the TUP requirement for mobile vendors
- Considerations:
  - No Site Plan required
  - Minimizes staff application review time but may result in more issues in the field with non compliance

# Ordinance 751-21 & TC Text Amendments

- Updating fee and definitions
- New section to TC for Mobile Food Vending
  - Can operate in non - residential districts (current requirement)
  - Allows for ice cream trucks
  - Allows for private catering events in residential districts (churches, parties, etc.)
  - Can operate 96 consecutive hours
  - Permits food unit parking in legal parking spaces
  - Allows only vehicles in the ROW (no push carts)
  - 6 hour parking limits in public ROW
  - Ensures private property parking requirements are met
  - Allows temporary signage
  - Requires trash receptacles, adequate lighting, and general site maintenance.
  - Fire code compliance
- Requirements are consistent with Chandler, Gilbert, and AZ League



# Proposed Motions



## Motion No. 1 (Option 1 – Peddler’s License)

- Motion to approve Ordinance 751-21, an amendment to the Town Code Chapter 8 Business regulations for Mobile Food Vendors, by amending Code Articles 8-1 (Business License) and 8-2 (Peddlers, Solicitors and Transient Merchants) and creating a new Section 8-2-14 MOBILE FOOD VENDING Town Code Text Amendment, Mobile Food Vendors, adopting Option 1 for licensing and fees for Mobile Food Vendors.

## Motion No. 2 (Option 2 – General Business License)

- Motion to approve Ordinance 751-21, an amendment to the Town Code Chapter 8 Business regulations for Mobile Food Vendors, by amending Code Articles 8-1 (Business License) and Section 8-2 (Peddler’s, Solicitors and Transient Merchants) and creating a new Section 8-1-13 MOBILE FOOD VENDING, adopting Option 2 for licensing and fees for Mobile Food Vendors.
