- 1. <u>Germann & Crismon GPA</u> The current General Plan Designation for land located at Germann & Crismon is Industrial and the applicant is proposing Industrial and Neighbor Designation.
- 2. <u>Encanto Vista GPA</u> Located at the southern end of Town bordering the San Tan Mountains. Currently designated as Rural and the proposed General Plan Designation is Neighborhood.
