B. Discussion and possible recommendation to Town Council on a preferred design concept for the East Park site - Adam Robinson

Adam provided a review of the three updated design concepts and the edits made based on PRAC, staff and stakeholder feedback.

Discussion/Questions/Comments:

 Pleased with all the updates and preferred concept #3 with the fields together and no parking on Signal Butte

- Great job overall and will be challenging to select just one.
- Outstanding renderings!
- Really likes concept #3 with the fields together and the parking available by all the fields, courts and no parking on Signal Butte to showcase the lake and green space
- Multigen Center is based off of 50,000 square feet, standard size for most communities
- The multigen center is placed well in concept #3 as it is near the lake for views and the courts for equipment checkouts
- Concerns about the size of amphitheater, would hope it could accommodate larger events and activities
- As an engineer, like the aesthetic and flow of concept #1
- Concept #2 seems like there is more room for the multigen center to reconfigure it once it is designed, more space could also probably be added to concept #3
- Love 3x3 ball field setup bottom middle field will have issues with pop up foul balls hitting around the concession stand
 - o Great point! Possible solution would be extended netting or repositioning
- Concept #2 move bleachers closer to the parking lot on the multipurpose fields, doesn't care for the multigen center being right smack in the center because it could obstruct views
- Concept #1 Same thing with multigen obstructing views
- Concept #3 likes the centrally located parking and flow of the park overall, concerns with the fields being far removed from the play area and courts
 - There is a small play area within the ball field area
- Like the amphitheater area on concept #1 as it had its own designated green space
- Possible benefit in switching the multigen with the playground so parents could watch sports and little ones at the same time, in concept #3
 - Other members like the playground where it is as the multigen center has its own parking to the north
- View of the lake being blocked when the multigen center is right next to the lake
- Will the centralized parking lot cause congestion during high traffic times for tournaments or games?
 - Main entrance for all concepts is Ryan Rd, would use wayfinding signs to direct people to sections of the park
- Appreciates the view of the lake off of Signal Butte
- Majority prefers Concept #3, focusing in on Concept #3
 - o Does the amphitheater allow spillover into the multipurpose fields?
 - Yes, would be built to allow spillover
 - Potential for dual use as a large ramada
 - Would recommend having another exit on the top of the big center parking lot?
 - Right turn in and right turn out
 - Is concession a need near the multipurpose fields?
 - Yes, we do not have games at Mansel Park because there is no concession. In addition, there is a need for storage in this area.
