Enterprise Finance Manager Jessica Platt gave a brief presentation on initiating a third party collection service and adding a collection service fee for delinquent accounts. She said it is a two-step process and tonight is the public hearing for possible adoption of the Ordinance to amend the Town Code to create a collection fee not to exceed 15% of the delinquent balance. If approved it would be effective on November 6, 2021.

Ms. Platt said we are one of the few towns that does not use a collection agency. She pointed out that the use of the collection agency is a last resort and said the Town does a good job of notifying customers and offering payment arrangements.

Ms. Platt outlined the contract terms and said the agency charges a 15% collection fee for their services, which would be paid by the delinquent customer.

Mayor Barney opened the public hearing. There were no comments from the public or the Council and the public hearing was closed.

Patrick Copeland, consultant from HeinfeldMeech, presented an overview of the Biennial Development Impact Fee Audit results. He said that in compliance with Arizona statute the audit must be done by a qualified professional not working for the town; be posted on the website; and must hold a public hearing within 60 days of release of the audit report to the public.

Mr. Copeland summarized the Agreed Upon Procedures (AUP) that were performed in the audit and reviewed the Town's results. The only exception found was a variance in the growth estimates provide by the Town regarding population, housing permits and nonresidential square footage. There were no other exceptions identified and the Town's impact fee program and practices are in compliance. Mr. Copeland thanked staff for their assistance, in particular Matthew Rheames.

Deputy Finance Director Dan Olsen followed up with a summary of permit activity showing growth in several areas. He said that revenues collected by impact fees totaled \$50.4M and expense activity was \$21.5M, with the largest amount spent on streets.
