Deputy Utilities Director Mark Skocypec presented a recommendation to further reduce CAGR fees by \$0.6M for our water customers. He provided a high level background on how prior Council actions and policies helped to manage costs. He said the recommendation also includes a policy to reduce post 2004 water account bills and also adds a requirement to produce an annual report with pertinent financial information.

Council thanked staff for implementing policies and actions that will benefit our tax payers and reduce annual costs.
