A. Transportation Department Update by Mohamed Youssef.

<u>Public Works Department Presentation</u>

Public Works Director Mohamed Youssef provided the department mission statement, organization chart and a description of their core duties and said his team is on call and works 24/7. Mr. Youssef provided a detailed description of the following divisions that fall under Public Works:

<u>Pavement Preservation & Streets</u> - storm water systems, bridges, culverts, sidewalks, signage, roads

<u>Environmental Division</u> - trash, recycling, dust control, hazardous waste program <u>Fleet Services</u> - maintains 450 vehicles and equipment

<u>Traffic Engineering</u> - reviews all Town applications, traffic analysis, traffic control, work safety zones, traffic signals

The commission had questions regarding traffic signal placement and the amount of traffic generated from SR24 and other large developments such as Costco. The commission thanked Mr. Youssef for his expertise and the knowledge he brings to

Queen Creek. They said they value the work that the Public Works Department and his team provides to the Town.
