3. Items for Discussion and Possible Action

A. Consideration and possible approval of the August 25, 2021 meeting minutes

B. Discussion on legal review and Open Meeting Law

Town Attorney Scott Holcomb explained the roles of the Board of Adjustment (BOA) as it relates to State statute (A.R.S. 9-462.06), the Town Code and the Town Zoning Ordinance. He provided some examples of hearings that the Board may hear such as variances, zoning interpretations, abandonment of non-conforming uses, or development permit revocation. He summarized the requirements needed to grant a variance and the rules of procedure, rules of evidence and burden of proof.

Attorney Holcomb reviewed meeting procedures including making motions and voting and said the BOA makes the final decision on items that come before it. The Board's decision can be appealed within 30 days in Superior Court.

Attorney Holcomb reviewed Open Meeting Law and conflicts of interest. He explained the elements of a meeting, quorums and gave examples of "splintering" the quorum using email, telephone, chat and other means of communication amongst members. He cautioned that if the communication involves public business, the public has a right to listen. He concluded with the consequences and penalties of violating Open Meeting Law.

Mr. Swanson provided a case example of a variance relating to unique topography of the land and outlined the requirements that must be met in order to grant a variance. He said that staff will provide information for review so the Board can make an informed decision.

C. Discussion and possible action on the Annual Organizational Meeting Notification (to set Chair and Vice-Chair appointments for the upcoming year)

Mr. Swanson introduced the item and the Board had a brief discussion on appointments.
