1) <u>Call to Order:</u>

The meeting was called to order at 6:30 p.m.

2) Roll Call:

3) Pledge of Allegiance:

4) Invocation/Moment of Silence:

A moment of silence was held for Preston Lord and all of the youth affected by teen violence.

5) Remarks from Mayor Julia Wheatley and QCPD Police Chief Randy Brice regarding the ongoing October 28 homicide investigation.

Mayor Wheatley thanked the community and the region for their support of Preston Lord's family and condemned the senseless unacceptable acts of violence. She expressed her sympathy for Preston's family, friends, classmates and teammates. She spoke about the recent high school basketball game between Combs High School and Poston Butte High School where the teams came together in support of Preston and said we have seen acts of kindness and community support as a result of this tragedy.

Police Chief Randy Brice provided an update on the October 28 homicide investigation and said they continue to work to get this case to trial. Chief Brice said they are working with the County Attorney as they continue to review case. Both the

County Attorney's Office and QCPD are continuing to seek new information and asked the community to contact them if they have any information whatsoever. Chief Brice addressed the many public record requests that have been received on this case and said pending records are being redacted and cannot be released until they get to a certain point in the investigation. He said the focus continues to be on justice for Preston and finding a solution to teen violence. He said this is a top prioroty and they are committed to the case, the community and the teen violence effort.

Mayor Wheatley spoke about the second meeting of "For Our Town" on Jan 23. She said the attendance and response from the group was encouraging in regards to ideas to reach out to our youth and get them involved in discussions. Mayor Wheatley announced the creation a Mayor's Youth Advisory Committee. She said we are currently hiring for the individual who will oversee that program, in addition to the teen programming at the new Recreation Center.

Connor Jarnagan, high school student from Queen Creek, spoke of his assault and expressed support of Senate Bill 1183 regarding brass knuckles; prohibited weapons.

6) <u>Ceremonial Matters (Presentations, Proclamations, Awards, Guest Introductions and Announcements):</u>

6.A) <u>Proclamation: Teen Dating Violence Awareness and Prevention Month</u>

Mayor Wheatley read the proclamation for Teen Dating Violence and Prevention Month and said it is an important reminder that all forms of violence are unacceptable.

Council Member McClure read the School Resource Officer Appreciation Day Proclamation and said it is a critical element of community policing strategies. The Council took photos with several Queen Creek Department School Resource Officers who were in attendance.

Mayor Wheatley read the proclamation in honor of Brock Purdy who is a Queen Creek native and a positive role model for leadership on and off the field. Mayor Wheatley wished him great success in Super Bowl 58 on Sunday, February 11, 2024.

6.D) Proclamation: Black History Month

Council Member Brown read the proclamation for Black History Month and encouraged all Queen Creek residents to join in celebrating the contributions of African Americans to our community, state and nation. He said several members of the Council attended the reading of the proclamation hosted by the Black Heritage Connection at Desert Mountain Park last Saturday, February 3.

6.E) <u>Proclamation: Blue Star Mother's Day</u>

Vice Mayor Martineau read the proclamation for Blue Star Mother's Day which was founded with the purpose of uniting mothers with sons or daughters in the United States Armed Forces. She said the Council is grateful for our service men and women and in Queen Creek and their families.

Council presented the proclamation to Bridgette Crosby and several members of the Queen Creek Blue Star Mothers who were in attendance and recognized them for their sacrifice.

12) <u>Items for Discussion:</u>

12.A) <u>Presentation on the status of the State Route 24 Extension approved FY 2024-2025 State Budget Appropriation.</u>

Department: Town Manager's Office

Intergovernmental Relations Director Heather Wilkey provided an overview of the SR24 extension and said Queen Creek's focus is on the Phase I portion from Ellsworth to Ironwood. She said the extension is in the interim status and Proposition 479 funding would complete this section to permanent status with full interchanges at Signal Butte and Meridian roads.

Ms. Wilkey said SB1722 was passed and appropriated \$87.5M to Queen Creek

and Pinal County to expend the funding for completion of SR24, which is still outstanding to date. She discussed the timeline in relation to the funding and discussed the Intergovernmental Agreement (IGA) details with the Town and ADOT to receive the funding. She said there have been many attempts by the Town to check on the funding status, including letters to the governor. Ms. Wilkey noted that we are one of two outstanding projects that have not received funding. She discussed the State budget process which included the proposed clawback of the SR24 extension and the Pinal Parkway and the \$87.5M funding which is needed to complete the project.

Public Works Director Mohamed Youssef discussed the consequences of a funding delay to Queen Creek and highlighted the rapid population growth in the area now and proposed for the future. He compared the number of interchanges serving the Chandler and Gilbert area versus the number of interchanges in Queen Creek and San Tan Valley and stressed the needs for this area due to the rapid economic growth. He said the extension is needed to meet level of services and discussed already at capacity conditions at Ellsworth and Ironwood roads. He said the money allocated that has been cut from the budget is absolutely needed. Mr. Youssef added that all the regional traffic studies included the Pinal Parkway and the SR24 extensions and without funding he said the studies are essentially invalid.

Ms. Wilkey said we will continue to advocate support for the appropriations to our legislature and work with other jurisdictions and partners and to raise public awareness.

Mayor Wheatley stressed the significance of this funding for the entire region and specifically the State Trust land that benefits the State and said letters from the Town have been unanswered at the governor level.

Representative Neal Carter, District 15, spoke in support of Queen Creek and SR24. He said it is a priority project and he said he was shocked that the money has not been released. He said he continues to work on behalf of this project and is opposed to the clawback of SR24 funding.

Council thanked Representative Neal for the support and for attending the meeting tonight. They asked him to keep up the good work on behalf of Queen Creek and the region.

<u>Presentation - Germann Road Realignment.pdf</u>

Capital Improvement Project (CIP) Director Dave Lipinski presented the Intergovernmental Agreement (IGA) with Pinal County and Queen Creek for funding of a portion of the design and construction of a realigned Germann Road between Ironwood and Kentworthy. He said as part of the development agreement with LG the Town is obligated to construct six miles of infrastructure to service the site. He explained the reason for the realignment was based on a new traffic analysis for projected traffic volumes regarding additional phases of development for the LG project. Mr. Lipinski said at this point the Town stopped final design and focused on finding alternative alignment solutions.

Mr. Lipinski said the Town organized meetings with the stakeholders involved including SRP, Pinal County, LG and the Arizona State Land Department which resulted in the proposed realignment of Germann Rd. He discussed some challenges involved with the realignment, but said the final realignment was a mutually beneficially agreement between all parties and the IGA solidified the funding agreement between the Town and Pinal County to complete the project.

Council discussed the significance of the collaboration between all parties to find a solution. Council appreciated the expedited timeline and a solution that benefited the area residents and the business community. They appreciated that it did not increase Town funding and thanked Pinal County for their portion of the project.

Finance Director Scott McCarty presented the 5-Year Operating Budget Revenue forecast. He said the purpose of the presentation is to 1) amend the FY23-24 adopted revenue estimates based on actual activity and 2) present the 5-Year forecast beginning with the next fiscal year starting on July 1.

Mr. McCarty discussed the uncertainty in the overall economy and highlighted some of Queen Creek's strengths. He said the actual results of the FY23-24 budget were better than expected and provided revised projections and introduced new policy decisions in regards to pay-as-you-go infrastructure funding. Mr. McCarty gave a detailed report on FY24-25 budget projections; long-term projections; population projections; housing permits and sales tax.

Council thanked Mr. McCarty for the thorough presentation. Mayor Wheatley commented on the economic development strides made in Queen Creek as a community over the years and the continued conservative approach to save for the future. Vice Mayor Martineau appreciated the cap and the policies put in place to look ahead to coming years.
