## 5) <u>Remarks from Vice Mayor Leah Martineau and QCPD Police Chief Randy Brice</u> regarding the ongoing October 28 homicide investigation.

Vice Mayor Martineau provided brief comments on the tragic homicide of Preston Lord. She said the QCPD provides regular updates on the investigation at Council meetings, however they are actively involved in a police operation at this time and are unavailable. She said the Chief will provide an update as soon as possible and a press conference is anticipated this evening.

Vice Mayor Martineau thanked the Maricopa County Attorney's Office and the Police Department for their efforts on this case and said it remains a top priority. She said the

12.A) <u>Presentation and update by J. Brian O'Neill, Executive Director for the Phoenix-Mesa Gateway Airport</u>

### Phoenix-Mesa Gateway Airport Presentation 🥯

Airport Executive Director Brian O'Neill thanked the Town for their support as one of the owners of the Phoenix-Mesa Gateway Airport. He discussed the airport mission and said the airport is an economic engine and job creator for the area. He focused his presentation on the commercial air service, new and completed projects and private development which is ongoing at the airport.

Council inquired about future improvements to Sossaman Road as it is sometimes used as a cut through to the 202 Freeway. Mr. O'Neill noted Sossaman Road as a major connector and indicated the Airport was working with partners in the area to minimize bottlenecking and improve traffic flows.

Capital Improvements Project (CIP) Director Dave Lipinski provided the quarterly update on active 10-year IIP Roadway Projects and said there is a lot of construction in progress to be completed this quarter. He provided updates on the Meridian Road at Queen Creek/Pima Road with a completion in August; Town Center roadway projects and pocket parks are ongoing; Ocotillo from Sossaman to Hawes (three phase project); Signal Butte: Ocotillo to Queen Creek; and the traffic signal at Germann & 196th has been turned on. Mr. Lipinski reviewed construction projects at Mansel Carter Phase 2; Frontier Family Park; Aquatic and Recreation Center; the Arizona State Land Department Infrastructure and the LG Site Development.

Council Member Brown asked about the Ocotillo: Sossaman to Hawes completion and asked if there will be any work in that area by Queen Creek Irrigation District (QCID). Mr. Lipinski said we are working extensivily with QCID and believe any issues have been squared away.

Proposed Calendar to Update Development Impact Fees Solution

Presentation: Impact Fees: Beginning the Update Process

Draft Report: Land Use Assumptions and Infrastructure Improvement Plan (dated February 28, 2024)

Finance Director Scott McCarty reviewed infrastructure needs and funding and discussed how the Development Impact Fee Program helps offset costs related to growth. He reviewed four areas of needed infrastructure totaling \$731M over the next ten years (Parks & Trails; Streets; Police; Fire/Medical). Mr. McCarty said the process to update the impact fees will take nine months and emphasized that existing residents and businesses do not pay impact fees and said Queen Creek does not have a secondary property tax for infrastructure.

Mr. McCarty outlined the steps for updating the impact fees and said State law has many requirements regarding the process. Staff and the consultants determine land use assumptions, determine the infrastrcture plans and calculate maximum allowable fees. He said the Council's role in the process will be to determine the allocation of the 2% dedicated construction sales tax and to set the impact fee amounts which will take place several months from now.

Mr. McCarty provided detailed information on Land Use Assumptions (LUA) and what needs to be built in terms of infrastructure. He discussed the expected growth projections and population estimates over the next ten years but noted that this does not include any State Land projections associated with LG. Mr. McCarty explained how costs are allocated by fee type for those projects that are eligible for impact fees. He reviewed the background on the dedicated 2% construction sales tax which we have been using to pay for new roads in Queen Creek. He discussed the possibility of expanding it for other uses such as police and fire and how it could effect the impact fee calculation and the timing. Mr. McCarty concluded with the next steps needed in the process and the proposed calendar for the fee update.
