#### **RESOLUTION NO. 1608-24**

A RESOLUTION OF THE COMMON COUNCIL OF THE TOWN OF QUEEN CREEK, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 30, 2024; AND ORDERING THE RECORDING OF THIS RESOLUTION.

WHEREAS, the Common Council of Queen Creek, Arizona did cause to be submitted to the qualified electors of the Town at a Primary Election called and held in and for the Town on the 30<sup>th</sup> day of July 2024 for the election of three (3) Council Members; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town; and

**NOW, THEREFORE, BE IT RESOLVED** by the Common Council of the Town of Queen Creek, Arizona, as follows:

- A.R.S. § 9-821.01 sets forth the procedure for calculating the majority of votes cast at a primary election in order for a candidate to win at the primary by adding all of the votes cast for all candidates for an office, dividing by the number of seats to be filled, and then dividing the result of the calculation by two, and rounding to the highest whole number.
- Section 2: That the total number of ballots cast at said Primary Election, as shown in the "Precinct Canvass" provided by Maricopa county and Pinal County (Exhibit A) was 18,247.
- Section 3: That the number of rejected ballots as shown in the "Rejected Ballots" provided by Maricopa County and Pinal County (Exhibit B) was 48.
- Section 4: That the votes cast for candidates for Council Member as follows:

Section 5: That the calculation for determining the majority of votes for Council Member is as follows:

Total number of votes needed to win at the Primary is 4,866 or more.

Section 6:

That is hereby found, determined and declared of record that three candidates did receive more than one-half of the total number of valid votes cast. Per A.R.S. § 9-821.01(E), "candidates who receive the highest number of votes equal to the number of seats to be filled for the office is declared to that office," and hereby issued a Certificate of Election:
