3. Parliamentary procedures and open meeting law training by Rebecca Zaudtke, Deputy City Clerk, City of Phoenix.

Rebecca Zaudtke, Deputy City Clerk/Open Meeting Law Coordinator with the City of Phoenix presented the history of Robert's Rules of Order and common practices for conducting a meeting including agenda requirements. Other highlights were:

- Agenda setting city policy
- Conducting the meeting debate (discussion) & decorum (behavior)
- Types of motions Basic: main/original; amended and substitute. The procedure for voting on amendments was also explained
- Tie votes the motion fails but not the agenda item and a new motion can be entertained

There was some discussion on the retention of tapes and videos of Council meetings. Town Manager Kross said that a staff records retention committee was formed to analyze the Town's current retention schedule.
