4. Discussion on Town annexation policy and procedures.

Planning Manager Wayne Balmer and Financial Services Analyst Kevin Johnson used the General Plan Map to review areas of potential future annexations, the current annexation policy and the annexation process which is set by state statute. The annexation policy requires a cost benefit analysis to determine costs for capital improvements upgrades, maintenance of pre-existing conditions, additional public safety service and compatible zoning. Possible benefits include collection of taxes, fees and shared revenue.

Council commented that annexations need to be manageable and affordable.

5. Council reports on meetings and/or conferences attended. This may include but is not limited to Phoenix-Mesa Gateway Airport; MAG; East Valley Partnership; CAAG. The Council will not propose, discuss, deliberate or take legal action on any matter in the summary unless the specific matter is properly noticed for legal action.

Council Member Mortensen reported on the East Valley Partnership meeting. Agenda items included a state budget briefing and ASU partnerships with others to form an aerospace institute at ASU Polytechnic.
