1. Call to Order

The meeting was called to order at 7:00pm.

6. Committee Reports

- A. Council summary reports on meetings and/or conferences attended. This may include but is not limited to Phoenix-Mesa Gateway Airport; MAG; East Valley Partnership; CAAG. - B. Town Center Committee October 27, 2009: Cynthia Buffington, Committee Chair, reported on the Committee's recommendations for decorative street lights on Town Center arterial roads, Town Center Amenities Element and a directional sign policy. Assistant Town Manager Patrick Flynn gave an overview of the procedure to adopt the Home Rule and stated that Queen Creek voters first approved Home Rule in 2002 and renewed it in 2006. Mr. Flynn said that Home Rule allows the Town to expend the revenue it generates, otherwise the Town would be under a State mandated limit.

The Public Hearing was opened. No one came forth and the Public Hearing was closed.

The Regular Meeting was recessed at 7:24 in order to hold the Special Session.

The Regular Meeting reconvened at 7:27.

10. Presentation by CMC Steel.

Steve Henderson, VP and General Manager of CMC Arizona, provided background information on steel manufacturing and uses for steel. He said the primary product manufactured at the Mesa plant is rebar made from recycled scrap metal. Mr. Henderson reported that 30 of the 135 current employees have Queen Creek addresses and during the construction phase and ramp-up operation, many other employees/workers used local Queen Creek businesses.

11. Presentation on the Intelligent Transportation System (ITS).

Assistant PW Director/Traffic Engineer Mike Pacelli gave an update and progress report on the Town's ITS program. Mr. Pacelli explained that the ITS monitors and manages traffic on arterial streets and coordinates traffic signals. He added that other uses include CCTV at intersections, dynamic message signs and linked communications to the traffic management center.

Mr. Pacelli said that the Town has been awarded six (6) federally funded grants totaling \$1.6 million and the first project, the "Town Center ITS" is underway. Mr. Pacelli reviewed the grant and match amounts.

12. Presentation on end of session legislative report by Mike Williams of Williams Associates.

Mike Williams, the Town's state lobbyist, reported on a few highlights that affected the Town from the past Legislative Session. Highlights he reported on:

- Congestion Mitigation Fund extension of loan repayment term now 15 years
- Development Fees

- Government transparency
- GPLET economic development tools
- Vehicle License Tax reduced revenue to cities & towns
- Police & Fire liability protection

Mr. Williams also discussed the planned work for the next Legislative Session that includes protection of State Shared Revenue; Development Fee moratorium, economic development and State Trust Land reform. Town Manager John Kross added that the Town's 2010 legislative agenda would be presented to Council in December.

Council discussed aligning Queen Creek's legislative agenda with those resolutions adopted by the League Resolution Committee and focus on state shared revenues, development impact fees and economic development.
