3. Presentation by Economic Development on Town Center Plan

Economic Development Director Doreen Cott presented an update on the Town Center Plan, which has been under review and update by the Town Center Committee since February, 2009. The Committee is nearing completion of the update to the Town Center Plan and the Redevelopment Area Plan. Ms. Cott presented the proposed revisions, including in part the Town Center boundaries, the land use plan and mixed use definition.

Commissioner Moore questioned the increased density that would come from the potential multi-family on the Victoria parcel, stating his concern for the pressure it would put on the parks system. He also voice concerns over increasing the size of the mixed use areas in Town Center, questioning the feasibility of doing this and how the character of the Town Center would be maintained.
