1. Call to Order

Mayor Barney called the meeting to order at 7:30pm.

2. Roll Call (one or more members of the Council may participate by telephone)

 - A. Volunteer Recognitions
 - Eagle Scout Jacob Johnson Mr. Johnson was recognized for his volunteer project of constructing a new sidewalk at the Queen Creek Library.

Council Member Benning:

- Meeting with State Legislators April 12: Council Member Benning, Vice Mayor Barnes and Wendy Kaserman met with legislators to lobby against SB 1525 (Development Fees statutes)
- Central Arizona Association of Governments (CAAG) Budget Committee April 19: The committee members reviewed the proposed CAAG FY12 budget; heard cost saving proposals from the new Executive Director Brian Tapp; and discussed the dues structure. The next meeting is May 11 in Marana.

Mayor Barney:

- Phoenix-Mesa Gateway Airport Authority –April 18: The Board approved a contract to construct new restrooms at one of the hangars and a 6-month property lease agreement with Jetstrip, Inc. The next meeting is May 23.
- American Planning Association Conference: attended sessions on finance, fees, and budgeting.

Council asked if there were any tips or suggestions so Queen Creek could be ready for a similar project. Mr. Barney said to be in control of the things Queen Creek can be in control of such as infrastructure in the employment areas and be engaged and involved in the community and region.

10. Economic Development update.

Economic Development Director Doreen Cott presented an update on the 2010-2011 Action Plan and accomplishments to date. Areas of note include business attraction; SWOT analysis; Town Center Committee actions and working to promote existing Town events and entertainment activities. Also participation in activities with the Phoenix-Mesa Gateway Airport Trade area, Greater Phoenix Economic Council and other professional organizations. Ms. Cott included activities with the Queen Creek Chamber of Commerce, Rio Salado Community College and the creation of the business incubator program "QC Inc.".
