1. Call to Order

4. Presentation by Cox Communications on their system progress in Queen Creek.

Michael Stull, Manager of Government Relations with Cox Communications, reported on the following:

- Local & state charitable contributions (including free cable service to municipal buildings)
- Outage minutes of 2006 & 2007
- Planned improvements includes expanded HD, telephone, wireless, VOD & Interactive TV.
- Expanded bandwidth

Mr. Stull also discussed customer notification of changes in service and explained the digital transition from analog service which will be required by February 2009.

Council asked what efforts Cox was making to reach areas not currently served by cable. Mr. Stull said that Cox inherited the system and encouraged the Town to continue to require new developers to contact Cox. He said that costs are an issue for older neighborhoods not currently serviced.

5. Discussion on a Fiber to Home Feasibility Study.

Dee Anne Thomas, Director of Communications & Marketing, provided some background information on the Broadband & Telecommunications Assessment and previous direction from Council to look at several areas of the assessment, including the Fiber to Home element.

Lester Godsey, IT Division Manager, discussed the status of the municipal wireless network with design completed in November 2007. He provided information on the Fiber to Home (FTTH) that will improve telecommunications town wide; and stated that evaluation and planning would be necessary before implementing. Council asked if FTTH would be redundant with broadband. Mr. Godsey said that the feasibility study would answer that question.

6. Presentation on 2006 crime statistics for the Town of Queen Creek.
