**Process Overview** 





#### Non-profit Funding Process

- Application process to request funding.
- Application packages are mailed to nonprofits on file with Town during the budget development process.

### **Application Requirements**

- A summary of the organization, including: history, current services, list of officers and directors, current staff, service location, and future goals.
- A summary of the proposal, including: a description of the proposal; the population to which the proposal is being offered; the expected participation; the benefit to the community; the date(s) and location; the intended use of the proceeds; and any other sponsors and their contributions.
- The amount being requested, including the amount of in-kind support needed by the Town.
- Each non-profit event that receives funding is required to complete the In-Kind Service Report form after the completion of their event.



#### **Application Review**

- The Budget Office collects applications, reviews them for completeness, and compiles them into binders to be distributed to the Town Manager, Assistant Town Manager, and Budget Committee.
- The Town Manager's recommended budget goes to the Budget Committee for review with a place holder amount for non-profit funding.



### Budget Committee Review

- Budget Committee reviews the nonprofits' requests for funding.
- Specific meeting date(s) scheduled, and applicants invited to attend and answer questions.
- Budget Committee decides on a funding amount for each application. This funding is included in their budget recommendation to the Council.



## Possible Alternatives for Discussion

- Consider partners or contractors separately from the non-profit requests for funding.
  - Organizations that provide services the Town would otherwise fund.
  - Agencies the Council may want to provide for long term planning and stability.
  - Funded from departmental budgets.
    - Contracts would still be approved by Council, and would still be required to meet performance standards and provide quarterly reports.
  - Chamber of Commerce, Boys & Girls Club, others?



#### Possible Alternatives for Discussion

- Designate a percentage of the budget to set aside for non-profit funding.
  - The amount of non-profit funding set aside in the FY12 budget was approximately 1.5% of the general fund revenue.
- Appoint a citizen's committee to review the non-profit requests for funding, and make a recommendation to Council.



# Possible Alternatives for Discussion

- Consider funding requests for nonprofit community events separately.
  - Total amount of funding for these events set by Council.
  - Applications reviewed by Parks and Recreation Advisory Committee, the Economic
     Development Commission, or other committee who makes recommendations to Council.



#### Other Municipalities' Non-profit Funding Examples

– Classic procurement process.

- Review by citizen's committee.

- No funding set aside in some cases.



### Next Steps

- Follow-up item from Council retreat.
  Depending on Council's comments, next steps would be:
  - Make amendments to the process based on Council's comments, and send the amended process to local non-profits for comments.
  - After the comment period, bring the revised process with comments back to the Council for final action on a Regular Session agenda
